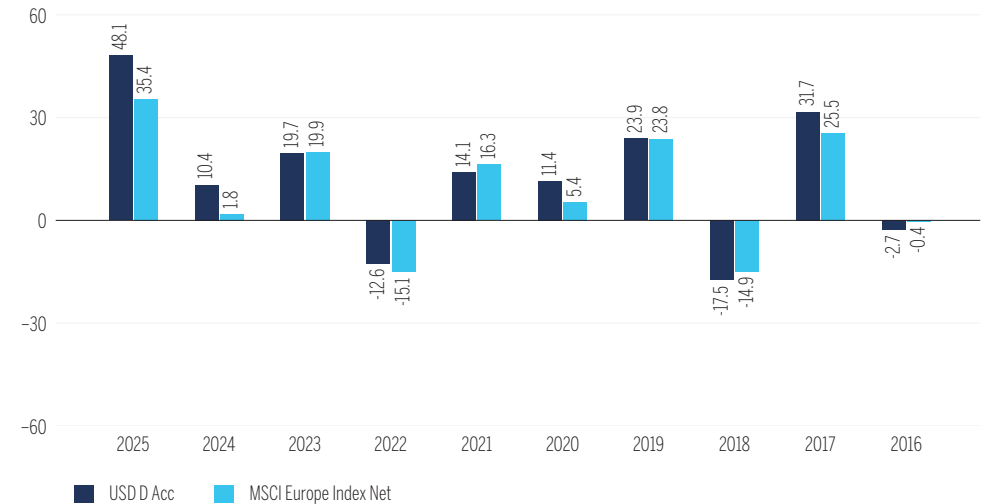

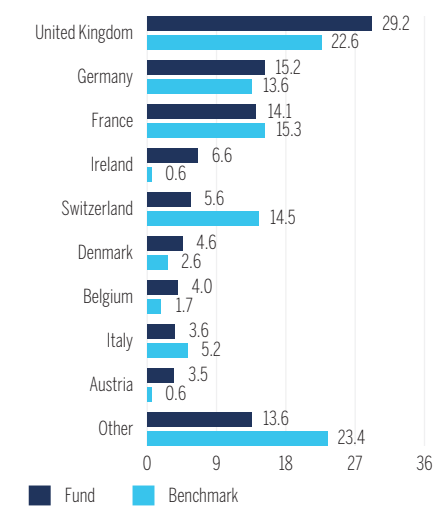

MARKET DISTRIBUTION

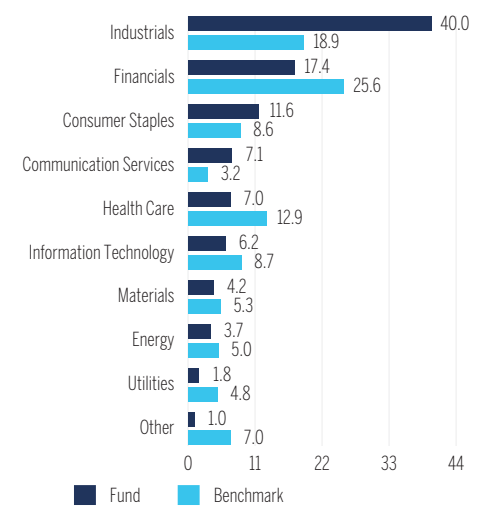
% OF EQUITY
